## आदेश

वैकल्पिक विकित्सा पद्धित (अल्टरनेटिय) की विभिन्न शाखाओं जिनमें इलेक्ट्रोपैथी/इलेक्ट्रो होम्योपैथी की मान्यता का मामला सरकार के विचाराधीन रहा । इस प्रक्रिया में सरकार ने माननीय दिल्ली उच्च न्यायालय की एक न्याय याचिका संख्या 4015/96 एवं ओ.एम.नं. 8468/97 के दिनांक 18-11-98 के आदेश पर विचार किया जिसने केन्द्र/राज्य सरकार को विचार कर स्थायी और नवीन संस्थाओं को लाइसेन्स आदि देने का कानून निर्माण करने का निदेश दिया था, जिससे अमान्य वैकल्पिक (अल्टरनेटिव) चिकित्सा पद्धितयों का विनियमन एवं नियंत्रण हो सके तथा सूचना प्रसारण के माध्यम से आम जनता को पर्याप्त जानकारी प्रतिवादियों के विषय में वैसी है । अन्य संस्थाओं जो सरकार और अन्य किसी परिषद से मान्यता प्राप्त नहीं है, हो सके ।

सरकार ने महानिदेशक, भारतीय चिकित्सा अनुसन्धान परिषद की अध्यक्षता में एक विशेषज्ञ समिति बनाई जिसके सदस्य चिकित्सा विभाग के विभिन्न क्षेत्र से लिए गये जो सरकार को अपने विचार और संस्तुति वैकल्पिक (अल्टरनेटिव) चिकित्सा पद्धति की विभिन्न शाखाओं की क्षमता/श्रेष्टता तथा माननीय न्यायालय द्वारा निर्देशित नियमों के बनाने की साध्यता का परीक्षण करके देती हैं।

समिति ने चिकित्सा की नवीन शाखा की मान्यता प्रदान करने के लिए आवश्यक एवं वांछनीय सिद्धान्तों की प्रगति तथा वैकल्पिक चिकित्सा पद्धित की विभिन्न शाखाओं जैसे आयुर्वेद, सिद्ध, युनानी, होम्योपैथी, योग और प्राकृतिक चिकित्सा (नेचुरोपैथी), इलेक्ट्रोपैथी/ इलेक्ट्रो होम्योपैथी, एक्यूपंचर, मैग्नेटोपैथी, रेकी, रिफ्लेक्योलॉजी, युरिनथेरपी/आटोरिनथेरेपी, हिप्नांथेरेपी, एरोथेरेपी, कलर थेरेपी, प्रैनिक हीलिंग, जेम्स एण्ड स्टोन थेरेपी और संगीत चिकित्सा का विश्लेषण किया ।

समिति ने इनमें से किसी भी वैकल्पिक चिकित्सा की वैधता को नहीं मान्य किया केवल पहले से मान्य व्यावसायिक परम्परागत चिकित्सा पद्धतियों यथा (आयुर्वेद, सिद्ध युनानी, होम्योंपैथी नेचुरोंपैथी और योग की समिति ने निर्धारित आवश्यक तथा वांछनीय सिद्धान्तों की प्रगति से पूर्ण होने के कारण, मान्यता के लायक माना ।

किसी भी तरह समिति ने संस्तुति पूर्वक कहा है कि निश्चित व्यवसाय एक्युपंचर और हिप्नोथैरेपी जो चिकित्सा पद्धतियों के दर्ज लायक है, इनको पंजीकृत चिकित्सा व्यवसायी इन पद्धतियों का प्रशिक्षण लेकर कर सकते हैं ।

समिति ने आगे सुझाव दिया कि चिकित्सा की वे सभी पद्धतियाँ जो मान्य नहीं हैं: उनकी पूर्णमासिक रनातक, परस्नातक डिग्री पाठ्यक्रम चलाने की अनुमित नहीं दी सकती तथा भारत सरकार द्वारा मान्य पद्धति (एलोपैथी, आयुर्वेद, होम्यो, यूनानी, सिद्ध, नेयुरोपैथी, योगा) के चिकित्सक ही अपने नाम के साथ 'डॉक्टर' शब्द प्रयोग करेंगे । जिन्हें चिकित्सा का माध्यम माना गया है उन्हें सर्टिफिकेट पाठ्यक्रम मानकर पंजीकृत चिकित्सा व्यवसायी के रूप में अपने अभ्यास में माध्यम के रूप में प्रयोग कर सकते है चाहे आधुनिक चिकित्सा पद्धति या नारतीय चिकित्सा पद्धति या होम्योपैथी ।

समिति की विभिन्न संस्तुतियों को सावधानी पूर्वक परीक्षण करने के पश्चात सरकार ने समिति की इन संस्तुतियों को स्वीकार किया जिसमें यह निवेदन किया गया है कि राज्य/संघ शासित राज्य सरकार निर्णय के प्रसार के लिए विस्तृत विज्ञापन दे सकती है। ये यह भी निर्णय कर सकते हैं कि जिसकी मान्यता के लिए संस्तुति नहीं की गयी है। राज्य/संघ शासित राज्य सरकार के अधीन संस्थान कोई भी डिग्री / डिप्तोमा चिकित्सा शाखा में प्रदान नहीं करेंगे तथा मान्यता प्राप्त चिकित्सा पद्धतियों (एलोपैथ, आयुर्वेद, होम्यो, यूनानी, नेचुरोपैथी और योगा) के चिकित्सा व्यवसायी ही अपने नाम के साथ 'डॉक्टर' शब्द का प्रयोग करेंगे।

#### ORDER

The matter regarding grant of recognition to the various streams of alternative medicine including electrospathy/electrohomeopathy, has been under consideration of the govt. In this process govt has considered the orders dated 18.11.98 of the Hon'bleHigh court of Delhi in CWP No. 4015/96 & Om No. 8468/97 which has inter-alia directed the central/State govts, to consider making legislation to grant of licenes to the existing and new institutes etc. to control & regulate the various 'unrecognised' streams of alternative medicines and also to give adequate publicity through media informing public about the 'Respondents' and similar other institutes not being recognized by the govt. & affiliated with any of the Councils.

Government constituted a "standing committee of Experts'under the chairmanship of Director general, Indian council of Medical Research and members were drawn from various fields of medicine to consider & give its recommendation to the Government. on the efficacy/merits of various streams of alternative medicine and also examine feasibility of making legislation as suggested by the Hon'ble court.

The committe developed essential & desirable criteria for grant of recognition to a new stream of medicine and analysed the different streams of 'Alternative medicine viz. Ayurveda, Siddha, Unani, Homoeopathy, Yoga & Naturopathy, electropathy/Electrohomoeopathy, Acupuncture, magnetotherapy, reiki, reflexology, Urine therapy/ autourine therapy, Hypnotherapy, Aromotherapy, colour therapy, pranic Healing, Gems & Stone therapy and Music therapy.

The committee did not recommented recognition to any of these alternative medicines except the already recognized traditional systems of medicines, viz, ayurveda, Siddha, Unani, Homeopathy and Yoga & Naturopathy which were found to fulfill the essential & desirable criteria developed by the committee for recognition of a system of medicine, the committee has however, recommended that certain practices as Acupuncture and Hypotherapy which quailied as modes of therapy, could be allowed to be practised by registered practitioners of appropriately trained personal, the committee further suggested that all those Systems of Medicine not recognized as separate systems should not be allowed to continue full time Bahelor and Master's degree coarses and the term "Doctor" should be used only by practitioners of systems of Medicine recognized by the Government of India, those considered as Mode of therapy can be conducted as Cerificate courses for registered medical practitioners to adopt these modes of therapy in their practice whether medicine or Indian systems of Medicine and Homoeopathy.

After carefull examining the varios recommendations of the committee the Government accepted these recommendations of the committee. Accordingly, it is requested that the State/UT Govt. may give wide publicity to the decision of the govt. they may also ensure that institutions under the State/UT do not grant any degree/ diploma in the stream of medicine which have not beem recommended for recognition and the term 'Doctor' is used by practitioners of recognized system of medicine.

- No. This order No.R-14015/25/96-U&H (PT) dated 25.11.2003 does not ban teaching of Naturopathy or awarding Diploma in Naturopathy.
- 2) No. Since Naturopathy is recognized as traditional system of medicines by Govt.of India, therefore under the provision of above Govt.of India order's practitioners of Naturopathy are allowed to use term ' Doctor' before their name.
- 3) No. There is no ban in the State of Punjab for running a private Institute and award Diploma in Naturopathy. However, at present there is no Board or Council regulating the teaching of Naturopathy in the State of Punjab.
- 4) Yes. A Naturopath can use the title of 'Doctor' as a suffix before his name in terms of above Govt. of India letter dated 25.11.2003.


